FINANCIAL REPORT/APPROVAL: Joey Catuara motioned to approve. Colin Lyon seconded. Yes: Majority

PRESENTATION/INTRODUCTION/OPENING COMMENTS: Ari Ruiz: The new U8 goals were returned for being too small. Larger U8 goals will be ordered.

BOARD MEMBER REPORTS:

Registrar: Registration is Wednesday, May 4, 2016 at Central Park from 6-8 p.m. Need parking monitor to help direct traffic to the back lot of Central Park. Need all the help we can get at registration. Matthew Sheasby sent 9,000 emails regarding registration.

Coach admin: There will be two dates for coaches clinics. Dates are still TBD.

Referee Admin: Referee classes for basic and U8 will have three dates. A law clinic will be scheduled on a Wednesday. Advanced referee course will be in October. Referee points were dropped to 10 because of cancelled games. Teams will needs 10 points by May 7, 2016 to advance to playoffs. Divisionals needs to remind coaches to remind parents not to yell at referees.

Game scheduler: Playoff schedule matrix ready. Possible rain 5/7/16. Seven U10 teams only have 1-2 points. U10 girls there are lots of teams also missing several points. Same with U12 girls. Can't make schedules until she knows which teams are advancing.

NEW BUSINESS:

Budget approval: Joey Catuara motioned to approve budget. Colin Lyon seconded. Budget accounted for 3% decrease in player registration. Yes: Majority; Abstentions: 4 Sandie has reviewed form for the budget and it needs to be fixed before submitting to National.

Vote for U14 Boys Extra Coach: Quint Sexton and Oscar Ortiz were not approved previously to coach extra team. Both Quint Sexton and Oscar Ortiz had a due process hearing. Oscar Ortiz was approved by due process team to coach extra. Parents from the current U14 boys extra team are present to discuss why the board doesn't have a process to mentor coaches. Appendix A: Changed language to hold back \$40 for admin fee.

Appendix B: Language added to state if a coach or team representative does not attend ratings night than the team cannot go on to playoffs. Discussion is had regarding not including new language in Appendix B. We do not want to punish the kids by disqualifying them from playoffs because of their coach. Vote to strike new language Yes: 10; No: 0; Abstentions: unknown

New language — Coach can only choose their own child and no other child for their team. If asst. coach has a child that child is also on head coach roster. If the head coach does not have an asst. they cannot pick another child. Sandie Oerly states a head coach can only pick their own child per National standard policies and protocols and it cannot be changed. Motion to

Took out language that states youth ref can only referee for one team. Changed language to state any referee cannot referee for more than two teams. Yes: Majority

Nancy Cooper makes motion to change age of youth referee to 10 years old. Jeff Gaines seconds. Discussion mainly states 10 is too young to referee. Majority: No. Motion fails.

U12/14 ARs may referee their own child's game before playoffs.

Appendix H – Select Teams:
